



**REQUEST FOR QUOTATIONS SUPPLY AND DELIVERY OF BEDS FOR
FEMALE RANGERS' HOUSES**

INTRODUCTION

The Maasai Mara Wildlife Conservancies Association invites qualified suppliers to submit quotations for the supply and delivery of beds for female rangers' houses located in Naibosho, Mara Ripoi, and Olderkesi Conservancies in Maasai Mara, Narok County. The purpose of this procurement is to furnish ranger accommodation facilities with durable, high-quality beds that meet required standards.

SCOPE OF WORK

The supplier will be expected to:

- Supply beds that meet agreed specifications and quality standards.
- Deliver the items to Naibosho, Mara Ripoi, and Olderkesi Conservancies within the agreed timeframe.
- Provide warranty terms for the supplied items.

MANDATORY REQUIREMENTS

Interested suppliers are required to submit the following documents and information:

- Valid Tax Compliance Certificate.
- Certificate of Registration/Business Incorporation and a valid Business Permit
- Evidence of at least two similar completed assignment (e.g., LPO, signed contract, or recommendation letter).
- Digital samples or product catalogues of similar works.
- Detailed financial quotation (inclusive of all taxes, transport, and delivery costs).
- Proposed delivery period (in days) from receipt of LPO.
- Proposed payment terms.
- Warranty terms for supplied products.

SELECTION AND EVALUATION CRITERIA

Supply and Delivery of Beds for Female Rangers' Houses in Naibosho, Mara Ripoi, and Olderkesi Conservancies in Maasai Mara

All bids/Quotations will be evaluated based on the following mandatory requirements and weighted criteria (Total: 100 marks).

1. Mandatory Compliance Documents (20 Marks)

- Valid Tax Compliance Certificate – 10 marks
- Certificate of Registration/Business Incorporation & Valid Business Permit – 10 marks

2. Technical Capacity (30 Marks)

- Evidence of at least two similar assignments (e.g., LPOs, signed contract, or recommendation letter) – 10 marks (5 marks for each)
- **Sample of proposed beds design – 20 marks**

3. Financial Proposal (25 Marks)

- Quotation with detailed cost breakdown – 20 marks
- Proposed payment terms – 5 marks

4. Delivery and Warranty (25 Marks)

- Delivery period from receipt of LPO – 10 marks
- Warranty terms (covering defects, replacement, etc.) – 15 marks
