## **INSTRUCTIONS TO BIDDERS**

**Note: This invitation is open for all bidders.**

1. This invitation is open to all eligible bidders.
2. Bidders shall bear all costs associated with the preparation and submission of their bids. MMWCA shall not be responsible or liable for such costs, regardless of the outcome of the bidding process.
3. Any requests for clarification must be submitted in writing via email to [procurement@maraconservancies.org](mailto:procurement@maraconservancies.org) with the subject line: "**Clarification – Bid for Disposal of Motor Vehicle – (Indicate Registration Number)**". Clarification requests must be received by **5th January 2026**. Responses will be issued in writing as of and when required.
4. Bidders shall indicate their bid prices for the vehicle(s) of interest in the attached Price Schedule.
5. All prices shall be quoted in Kenya Shillings (KES).
6. The motor vehicles offered for sale are second-hand.
7. The motor vehicles are sold strictly on an "as-is, where-is" basis and MMWCA shall not be liable for any defects discovered after sale.
8. Any attempt by a bidder to influence the bidding or evaluation process shall result in automatic disqualification.
9. Award shall be made to the highest responsive bidder, subject to MMWCA's internal reserve prices for each vehicle.
10. Successful bidders will be notified in writing and shall be required to make full payment within seven (7) working days from the date of notification. Failure to make payment within the stipulated period shall result in the award being offered to the next highest bidder.
11. Upon receipt of full payment, the successful bidder shall sign a sale agreement and collect the vehicle(s) within the period communicated by MMWCA. The buyer shall be responsible for all costs related to collection, loading, and transportation.
12. Risk and liability shall transfer to the buyer upon collection of the vehicle(s). MMWCA shall not be responsible for any loss, damage, or injury arising thereafter.
13. Transfer of ownership and logbook shall be processed after full payment is received and upon removal of all MMWCA branding from the purchased motor vehicle(s). Branding removal shall be the responsibility of the buyer.
14. MMWCA reserves the right to accept or reject any part or the entire tender without assigning any reasons.
